

Survey on Federal Emergency Aid Measures

and the Arts Sector

April 6, 2020

The Canada Council for the Arts is collecting information from its clients to better understand how the Government of Canada's recently announced support mechanisms for Canadian workers and businesses address the challenges and needs of the professional arts sector during COVID-19. This survey will enable the Council to better understand the issues facing individual artists and organizations and provide insights into what other initiatives may help the sector in this time of crisis.

This survey briefly outlines key federal emergency aid measures and poses a few questions about how they relate to you as an individual or as the representative of an arts organization.

The main support mechanisms announced by the federal government are:

For workers:

Canada Emergency Response Benefit: Wage earners, contract workers and self-employed people who don't qualify for employment insurance are all eligible. See information <u>here.</u>

For businesses, including non-profits and charitable organizations:

Canada Emergency Wage Subsidy: 75% wage subsidy to eligible employers for up to 12 weeks. See information <u>here</u>.

Canada Business Emergency Account: Interest-free loans of up to \$40,000 to small businesses and not-for-profits to help cover their operating costs. To qualify, organizations will need to demonstrate they paid between \$50,000 to \$1 million in total payroll in 2019. Applications should be made through the organization's current financial institution.

The survey will take approximately 15 minutes to answer. We ask that you please respond to the following questions to the best of your abilities with the information you have at this time. Note that all responses are confidential and that any public reporting will be in aggregate only, with no identifying information.
